Ordinance 2022-3 Municipal Court was discussed.

Discussed possible amendment to the Ordinance Chapter 3, Article 2, § 3-20 Licenses and tags for dogs.

Wendy Finley asked if the dog tags have been bought yet.  
Angela Shelton mentioned that for the last three months she has been getting food for the community. She has assisted with animals being spayed or neutered.  
Wendy and Angela both help correct a problem within the town limits when there was a problem within the Town. They both worked to correct the problem and get the dogs adopted.  
Concerns of Citizen's: Responsible people are the only ones that will comply, and others will ignore. Tags are just a way to make sure that animals have their rabies shot. People were stating that many buy their vaccines at Atwood's, and they tend to their own animal needs. Oklahoma requires that rabies be administered by licensed veterinarian. Adam made the motion to table until July regular scheduled meeting, Anita 2<sup>nd</sup> (all) Citizens did talk about their dogs getting loose, but they work very hard and try to keep animals in fences.  
Concerns about animals getting on the school grounds was talked about. If the animal had a tag, then they were able to get with the owner. Thomas Hayslip talked about using a gun with hollow point to correct the issue.  
Adam made the motion to table an agreement with an Animal shelter until he can find out more information. Though He has reached out to Snyder previously. Anita 2<sup>nd</sup> (all)

There were concerns about the water rates going up. Kaethe Hayslip kept telling individuals to get their own well. Chrystal stated that it would be ridiculous for water bill to be more than a car payment. Tammy Phares mentioned what would the Town do whenever people leave because they can't afford the water bill.
